## **Landscape Foreman Tigard, OR**

PHC Northwest's Landscaping department has an opening for a crew Foreman. This person will be directly responsible for the output of themselves and their crew. They will also be expected to provide training for trainees and employees that may be assigned to their crew. This position requires the Foreman to be capable of demonstrating proper and safe use of equipment and physically able to perform tasks such as weeding, raking, lifting/maneuvering up to 50 pounds, walking long distances and/or standing for long periods of time, carrying and loading materials and equipment. This position will take place primarily outdoors; work will occur in any kind of environmental condition.

### **Qualifications**

The ideal candidate will have a minimum of one year previous landscape experience and experience in a leadership/supervisory role. This position requires that the applicant has reliable transportation to job, clean driving record and current auto insurance to drive company vehicles.

An Oregon or Washington Commercial Pesticide Applicators license, CPR and First Aid certifications are not required at time of hire, but preferred. If selected for the position, the Foreman is responsible for obtaining these license/certifications.

This position will be from Monday through Friday, 40 hours a week. Wage will be \$14.11 an hour, and our Landscaping Crew are members of the Local 483 Union. Applicants must also pass a drug screen and background check.
